Important Information and Rules for GGRC Members

1. **Design and Construction** of each Residence Scheme will be based on the **plan approved by the Company.**
2. No member can make any change in their house without the permission of the Company.
3. In case, there is an **increase in the cost of Building Material (such as cement, steel etc.) above 10% of the original, then that 'extra amount' will have to be paid** by every respective member.
4. **No member is allowed to conduct any personal functions like 'Wedding ceremony'** or Religious activity in his/ her Residence or in Complex.
5. Member is however **allowed to welcome any of his family members in a weekend or any day** in his residence but **every person while residing there has to maintain our basic spiritual rules** in those days.
6. **Use of cigarettes, bidi, tobacco, gutkha, alcoholic drinks or any other unlawful activities is strictly prohibited**, either in his/her Residence or anywhere in the whole complex. If any such activity is found then the 'Management committee' of the company have the right to cancel their membership.
7. In the event of **death of a member**, as per 'the time value' of his/her house, amount will be paid to his legal heirs as per the Deed of Will executed by the member, if any. But, such **amount will be paid, after any other B.K. member purchases that property.** If however the heir or any of the family members is a B.K., who wants to stay there and follow all the rules and regulations of this Godly Institution, then the property can be transferred in the name of the legal heir and his family and will be permitted to stay in their Residence.
8. Member who **does not stay at his Residence at any time and wish to offer his house for the use by Retreat Centre for spiritual service activities, he will give the key of his Residence to the company.** If needed, he can keep one room in his possession, locked. The company will use his/her house for the purpose of Godly service. During this period, the company will take the responsibility towards its maintenance, cleaning etc. **Whenever the member wishes to come back and stay in his house, he will give advance intimation to the company at least 15 days before.**
9. The member while staying in his residence **has to follow the disciplined spiritual life and daily routine** like, Amritvela meditation, morning Murli class, evening NumashaamYoga, etc.
10. 'Management committee' of the company will have the right to take final Decision **to accept or reject the application for Membership** to anyone.
11. If any member **does not follow the rules** laid down by the GGRC or due to any reason **leaves, the Godly Knowledge** then such member will not be eligible to reside in the GGRC residential complex.
12. The 'Management committee' of the company will have the right to alter and/or amend any of the rules and regulations as and when necessary.

Important Note:

If any **member wants to cancel his booking in GGRC** due to any reason, his amount credited in GGRC, will not be given at that time. **When some other B.K. member will purchase his house, at that time his paid amount will be refunded.** Advance amount is Non-refundable in that case.

(In case of advance amount given for the Booking, 5% amount of the flat price will be retained for Godly Service, while rest will be refunded.)
